Introduction

This bibliography provides a list of sources about archival buildings published between 2000 and 2017. It continues the work of the International Council on Archives Committee on Archival Buildings in Temperate Climates and the Bibliography that they issued in 2003 as Volume 2.

This latest edition is meant to supplement the 2003 edition and contains bibliographic citations dating from 2000 to 2017. Some new classifications related to archival facilities have been added and some classifications have no citations at this time.

A few older citations are repeated in this volume because they are still considered current. When available, this edition provides a link to the online publication. Other sources that are related to archive buildings and that are not included in this Bibliography can be found in numerous other publications on cultural heritage institutions, museums and libraries.

Volume 3 of the ICA Bibliography on Archival Buildings and Equipment was completed by the ICA Expert Group on Archive Buildings and Environments from 2015 to 2017. Michele F. Pacifico, an Archival Facility Consultant in the United States, largely compiled it with assistance from Jonathan Rhys-Lewis. France Saïe-Belaïsch from the Directorate of the French Archives has worked on the French

Introduction
